1). Introductions

2). Houston Bike Plan – Presentation by Matthew Seubert, Planning & Development Department, City of Houston -- <http://houstonbikeplan.org/>

- 10 year goals – increased access, improve safety, develop & maintain facilities, increase ridership
- Houston has less than 1% Bike ridership, as opposed to most other cities with more than 2%
- To adopt the Bike Plan Chapter 33 has to be amended requiring a hearing and City Council approval.
- Additionally, Mr. Seubert discussed the ongoing Lower Westheimer Study to rebuild Westheimer and improve drainage, pedestrian access, safety and appearance. There will be a public workshop after Labor Day.
